## 3.0 Constituent Reports

# **Faculty**

Mr. Aylesworth presented the Faculty Constituent Report, highlighting the results of the Skills Canada competition noting the hard work and dedication of the faculty coaches. A copy of the handout is attached to the Minutes as Item # 3.0.1.

## **SCC Retirees Association**

Dr. Klein presented the 2012 Annual Report on behalf of the Retirees Association highlighting the following items from the Treasurer's Report:

• \$2,400 under College Grant is given by the President to continue activities.

- \$1,500 under Charity/Donations to be presented to the President in October to go towards the HealthPlex fund.
- \$750 under Travel goes towards sending a representative to the Ontario Colleges Retirees Association in Toronto.
- Dr. Klein also noted that at the Executive Meeting on May 16, 2012 there was some discussion around clarifying "support" and how the retirees support their 400 members. He indicated that the By-Law will be "tweaked" to reflect what they can support and what they cannot.

## 4.0 Business Arising

## 4.1 President's Report

At this time, Dr. Strasser indicated that Ms. Hetherington would use this time to discuss the 2012/2014 Advertising Campaign. Ms. Hetherington handed out the "St. Clair College Gryphon" (College newsletter) and presented a PowerPoint presentation highlighting the new Advertising Campaign. The newsletter is attached as item #4.1.1 and the presentation is attached as item # 4.1.2 to the Minutes.

Ms. Hetherington highlighted a few items from her presentation:

- The greater Toronto area (GTA) is an area that we are concentrating on.
- The demographics that they are targeting are ages 18 34.
- Advertised in all 650 subways in Toronto.
- Heavily involved in the recruitment in the GTA, 110 high schools in the west end of the city.
- St. Clair College participated in the Student Life Expo; this is a three day fair and had over 160,000 people attend.
- St. Clair College is the major sponsor for the Fun Run on June 9<sup>th</sup>, 2012. The Saint's bus and College cheerleaders will be participating as well.
- She noted that the possibilities are endless with the "HERE" campaign.
- Mr. Marcotte made a suggestion to Ms. Hetherington that "Get your medals HERE" could be another slogan to use.

# 5.0 New Business

5.1 New Program – Home Inspection College – Approved Certificate

At this time, Ms. France introduced Ms. Irene Moore-Davis to speak to this agenda item. Ms. Moore-Davis reviewed the submission that was attached to the agenda highlighting the following:

- There are ten 45 hour modules which are delivered online through OntarioLearn.
- There are no financial risks involved in the establishment of this program because the program is delivered online through OntarioLearn. Ms. Moore-Davis noted that there will be no added human resource costs to the College and no physical resources required.
- To ensure consistency across the province, the Post-Secondary Accountability Branch of the Ministry of Training, Colleges and Universities has asked all colleges to make a certificate available to students if they are offering the Home Inspection courses through OntarioLearn.

After some discussion, it was therefore,
