BREAKFAST WITH PRESIDENT PATTI

Your Retiree Executive is fortunate to be able to meet bi-annually with President Patti France and Vice President John Fairley to report on the activities of the Retirees' Association and to hear from President Patti on the latest events and developments at the college. At our April 17, 2018 meeting President Patti presented a comprehensive report on the current financial status of the college and future plans for addressing the college's financial position.

The college has been proud to be able to maintain a non-deficit position through some trying times over the past several years. However, three significant changes have created a serious strain on the college's finances:

First, the Ontario Government passed Bill 148. While making sweeping changes to the labour law, the change having the most impact on the college's finances is the increase in the minimum wage to \$15.00 per hour, over one year. The quickness of the change and the breadth of its impact was significant:

\$12M increase in the cost of part time faculty;
\$1.2M in increased indirect costs for contracted services and 3rd party costs.

Secondly, the unionization of part time staff has increased costs by \$2.7M

Thirdly, the Ontario Government has ordered the closure of St. Clair College's Toronto Campus which has been serving approximately 1,500 fee-paying international students. This will reduce revenue by \$6.7M. An extension has been granted to allow for the phase-out of these programs.

To address these issues, the president has introduced the possibility of a number of strategies to reduce cost and to increase revenue:

- Increase international student enrollment by 5,000 students (by 2021)starting immediately;
- Increase domestic enrollment;
- build an academic tower over the current Student Centre at a cost of \$20M, to accommodate these enrollment increases;
- design and build a SportsPark on the current playing fields south of the main building at South campus (\$15M already committed);
- investigate the building of a 3rd party parking structure on campus;
- build additional student residences at both Chatham and Windsor;
- expand the Student Centre (Academic Tower above) and additional services for a bank, pharmacy, espace, etc.;
- rationalize academic program offerings;
- develop Apps to help students navigate their way around campuses;
- create a centralized 'Welcome Centre' to provide students with a 'one-stop' service area.

While these strategies will not all be realized immediately, they are targets for gradual implementation and will significantly transform the St. Clair College we know today.

MEET YOUR NEW VICE PRESIDENT

Ross Langill was born in Windsor and lived in what was then Sandwich West. Dad was a jeweller in both Windsor and the US; mom was a late blooming teacher who started at the Sun Parlour School for the Developmentally Delayed; and younger

brother Ron lives in Waterloo and provides IT services for an insurance company.

Ross attended Ivor Chandler Public School and then split time in high school among Centennial, Massey and Sandwich West Secondary Schools.

Upon graduation he elected to go to St. Clair College for the Travel and Tourism Program taught by the likes of Jean Brechkow. Unfortunately, Ross found attending classes challenging. He then tried Business Common also to no avail although he values to this day the typing elective taught by Bernice Jewell and the friendship he developed with another elective teacher, Joe Lucas.

Although Ross loved being at St. Clair College, he was on the verge of gaining a diploma in Cafeteria Skills Management, when he was approached by fellow student Tom Markham who was active with student government and reported to Cal Haddad. Tom asked if Ross wanted to help the student government with marketing. So for three years Ross helped with developing flyers, working at the pub and radio station and doing lots of Devonshire Mall College Marketing. Then Ross became aware of the OCAP Program run by George Lewis and Florence Lytle. For one year, he was trained to do shipping and receiving under the tutelage of Sam Siddall. When Sam left for typewriting repair training, Ross took over, reporting to Chuck Harwood. In 1977 that job was posted as a full time opportunity and Ross jumped at it while later adding Mailroom duties to his resume.

In 1990 the New Democrats introduced the jobsOntario Program which assisted unemployed youth to access on the job training. Ross applied successfully for this work at the Eugenie Street location reporting to Ann Miskovsky. Then in 1995, when Mike Harris eliminated this program, Ross, faced with layoff, bumped into Parking Services, reporting to Brook Gardner.

In 2010 the newly founded Employment Ontario Program at the Roundhouse Centre offered work Ross was very familiar with. He worked there for three years reporting to Karen Gill-Gore until his retirement in 2013.

Ross has two daughters: Diane is a nurse and is married to Scott with children Violet and Simone. KellyAnne is working for a local factory performing automotive-related work.

In addition to having played his trombone with a number of bands over the years, Ross has also dabbled in theatre work. At the College, Ross was very active with Local 137 for a good 30 years, serving with (then) Jill Morgan and Sam Siddall as a VP and Secretary while also representing the Local at both Divisional and Provincial meetings. He also represented support staff for many years on Academic Council and worked with Al Hoffman and Brook Gardner drafting the Student Code of Conduct.

Ross values his time at the College and its family-like atmosphere. He is thoroughly enjoying his retirement and is excited to now work with the Retirees' Association.

A hobby in ceramics led to an opportunity to teach the same to developmentally delayed clients in ARC Industries. This led to opportunities to work as vocational counsellor and placement officer and even included working with our own Gord Crompton supervising student placements in the DSW Program.

At the same time, Susan was sent to York University where she obtained a diploma as an Adult Rehabilitation Worker. Predictably this experience wet her appetite for further education. Susan ultimately obtained a Masters Degree in Adult Education.

In 1987 St. Clair College posted a job for a Placement Officer in the Futures Program at Thames Campus reporting to Trish MacFarlane. After working there for three years, Susan transferred to the Windsor Futures Program on Janette Avenue reporting to Carol Libby. submitted by Pat Hallahan

Cutbacks in the Program resulted in work in Applied Arts as an administrative assistant to Virginia Macchiavello, after which she did a variety of jobs, including Youth Employment Counselling in Chatham and Windsor reporting to Jamie Wilson; Corporate and Professional Training on Rhodes Drive and South Campus; and work in Youth Employment Services reporting to Ron Seguin and Beth Pirouet in a variety of locations.

Eventually, Susan obtained work in pre-apprenticeship training and cooperative education. Ultimately, she achieved the position of Manager of Apprenticeship Programs (challenging role for a female) and Literacy and Basic Skills.

Susan's time at the College also included many years serving on Local 137, including time as its chief steward.

Susan retired in 2017 and has only fond memories of her time at the College and is very grateful for the many different opportunities afforded her.
